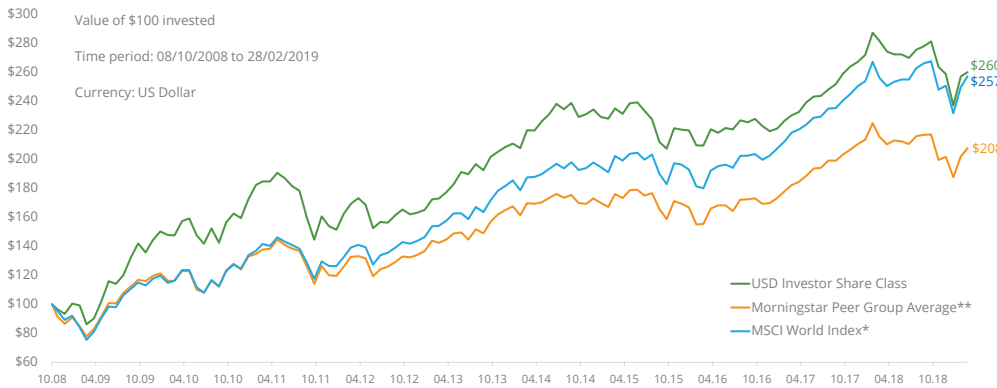

COMMENTARY

By the end of February, most large global companies had reported their 2018 full year and fourth quarter earnings. One broad observation across many industries was the deceleration of organic revenue growth and weaker performance at an operating income level in the last quarter of the year. For US-based companies, the strong US Dollar didn't help, but in many cases lower tax rates, "once off" accounting adjustments, and fewer shares in issue (thanks to share buybacks) saved the day and still allowed companies to report better earnings per share growth than the underlying business performance metrics suggested. This was particularly evident in the technology sector, where your fund has an underweight position. Large "bellwethers" such as Apple, Samsung, Oracle, IBM and Nvidia reported not only slowing revenue, but a decline in revenue in the last quarter. Even Facebook and Google, which reported "slowing" sales growth in the latest quarter of 30% and 22% respectively, only reported 6% and 7% growth at an operating income level. This was due to both companies increasing their workforces by 40% and 25% (+10,000 & +19,000) in 2018 respectively, and to higher depreciation charges on the capital expenditure of recent years. In 2018, Facebook & Google spent \$14bn and \$25bn on data centres, servers and network infrastructure (approximately 3x their depreciation charges), which led to a decline in free cash flow. What concerns us is that the higher costs from additional employees and a higher depreciation charge will weigh on future earnings growth, especially if sales unexpectedly slow in the years ahead. Despite Information Technology being the best performing sector in the MSCI World Index in February, we therefore see reasons to be cautious and are underweight IT. Your Fund's largest technology holding is Cisco, a leading networking infrastructure and security company. Cisco benefits from any internet, networking and security related expenditure, but unlike the other companies mentioned above, doesn't have the cost challenges of thousands of new employees, nor has to spend vast sums on server farms (capital expenditure has been less than depreciation for the past 3 years). Consequently, Cisco increased operating income faster than sales growth in 2018 and at a 6% free cash flow yield is twice the 3% free cash flow yield of Google and Facebook.

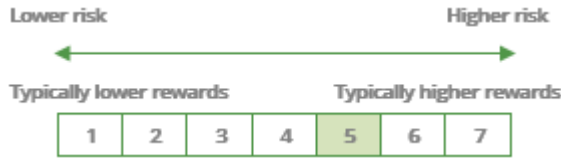
Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.
