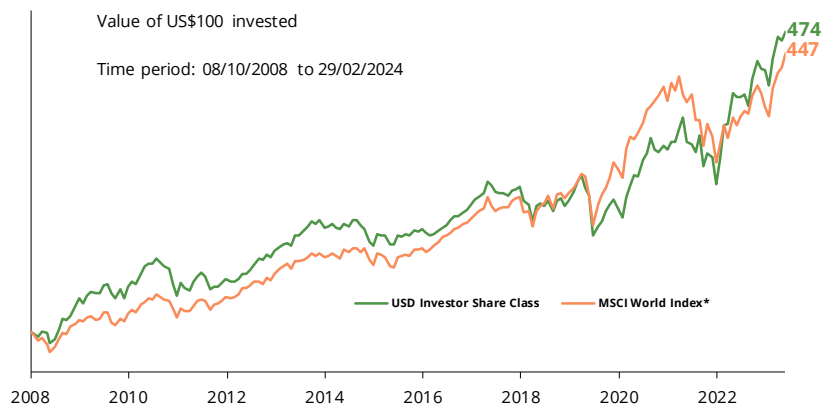

**COMMENTARY**

Hong Kong's Hang Seng Index (Total Return) has fallen 33% over the past 5 years, while the S&P500 Index is up 102%. We were not buying Chinese companies back then because the region was extremely popular. "Popular" often means "high prices" and paying high prices may work in the short-term if the momentum continues, but maths tells us that paying high prices depresses future returns over the long term.

Our investment style is to look for "diamonds in the dust", and so we have been increasing exposure to this out of favour region as we've found what we think are "diamonds". To be clear, we have not bought property companies, banks or insurance companies with exposure to property. Rather, we have been buying what we think are good businesses at great prices. It's starting to pay off because one of our largest contributors to February's performance was United Laboratories, a Hong Kong listed pharmaceutical company. It's a well-managed business with growing revenue and earnings, and priced at only 7x forward earnings.

In 2019, Chinese technology company Alibaba (another holding) was trading on a forward earnings multiple of 30x because of its growth outlook. The company has grown earnings since then, (slower than expected), and their net cash balance has almost tripled to \$94bn. Yet today you can buy it for 8x forward earnings.

The key concern most investors have with China is "political risk". But as 64 countries head to the polls in 2024, arguably the political risk in many developed countries is far higher.

Take the USA for example, where most investors have most of their equity exposure. The country is deeply divided with two aging politicians in the running - Biden (81) and Trump (77). At a company level, the Federal Trade Commission has multiple long-standing cases against the major technology companies, and in January launched new investigations into AI partnerships. If a recession arrives at a time of political change and division, or US-China relations deteriorate further with a Trump President, the backlash against many large US companies with Chinese exposure (Apple, Nvidia and Qualcomm) could be significant.

Yes, Chinese leadership has cracked down on technology companies in recent years (Ant Financial IPO cancelled in November 2020, online gaming restrictions in 2021), but these moves occurred prior to the recent deterioration of the Chinese property market. Technology companies and their start-ups are large employers, and in a tough economic market, this should count in their favour.

Political risk is always worth considering, but sometimes reality differs from perception. What we like about China is that risks are priced into the businesses we are buying, while some other markets little risk is priced in.

### Ongoing Charges Figure (OCF)

UCITS funds are required to calculate an OCF. It is a measure of the costs of operating the Fund. It is calculated in accordance with a methodology published by European regulators. The OCF of the Fund was 1.30%, calculated based on operating expenses of the Fund for the 12 month period ended 31/12/23 as a percentage of average Fund net assets of \$88.9m over the same period. The OCF includes all fund operating expenses for the USD, GBP and EUR investor classes, but excludes the 0.5% payable to the financial intermediary for the USD Advisor class.

The OCF figure is not applicable to the USD Institutional class. The Investment Manager has agreed with the Fund to rebate a portion, or all, of the Investment Management Fee attributable to the USD Institutional Class in order to facilitate the capping of the Capped Fees incurred by Shareholders in USD Institutional Class at an annualised 1.00%, subject to certain limitations. The OCF methodology does not include broker commissions, which were an additional 0.22% over the aforementioned period.

### Fund details

The Fund's benchmark is the MSCI World Index, a broad global equity benchmark that represents large and mid-cap equity performance across 23 developed markets. It covers approximately 85% of the free float-adjusted market cap in each country and does not offer exposure to emerging markets.

### Fund objective

The Fund is actively-managed and its investment objective is to outperform the MSCI World Index\* and to provide capital growth over a medium to long-term time horizon. The Investment Manager applies a bottom-up, "valued-based" research-driven stock picking method.

### Share class information

The USD Advisor class carries an additional 0.5% p.a fee which is paid to the financial intermediary.

The Ranmore Global Equity Fund GBP and EUR classes are not currency hedged classes. The difference between the returns in these classes and the USD class is due only to changes in the GBP/USD and EUR/USD exchange rates over the measurement period.
