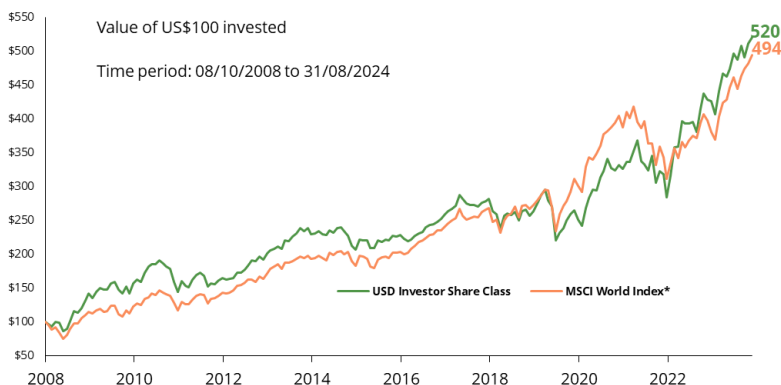

## COMMENTARY

Students of behavioural finance know that “biases” come in many forms which can impede investment performance. That’s one reason why we avoid meeting company management – charismatic and eloquent CEOs are easily and often confused as being “good management”. So we prefer to assess management by looking at the financial performance of the company under their watch – has Return on Assets increased? Have they gained market share? Have operating margins risen? Has cash generation improved? Are some of the questions we like to ask when assessing management during our investment research process.

One company which, through share price performance, has risen to be just outside our Top 10 at month-end, has generated an average Return on Equity over the past 10 years of 19%, (27% if you exclude losses suffered during COVID). The company has also tripled Revenue and net income over this period and their consistent cash generation has meant they have the strongest balance sheet in the industry, with net cash. You don’t need to meet this management team to know they’re the best in their industry. The company is the low-cost airline, Ryanair.

Part of Ryanair’s success is due to their opportune timing of aircraft purchases - when other airlines were cancelling aircraft orders after 9/11 and during COVID, Ryanair were buying (at great prices). Those great prices are how they’re able to offer low prices to their customers and generate higher returns than peers. This won’t surprise Value investors who know that low entry prices are a major factor in generating high returns.

Many investors would shudder at the thought of buying an airline because the poor industry performance over many years has created this “bias” against owning airlines. However, ignoring commonly held biases against other industries (banks), and regions (emerging markets) has been profitable for our clients and we’re hopeful that with Ryanair’s excellent management team in place, ignoring the common “bias” against airlines will be equally profitable.

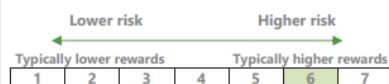
