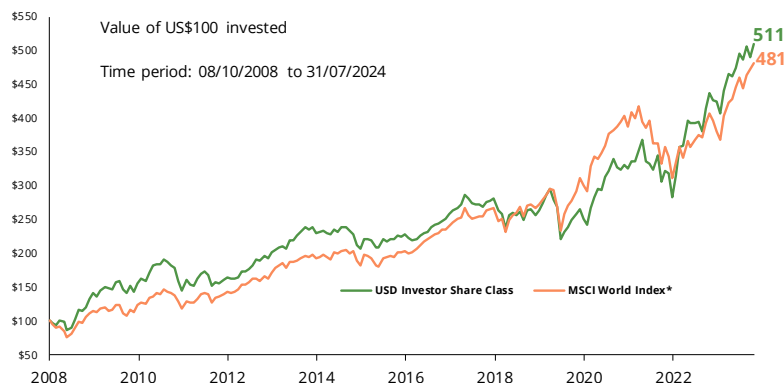

COMMENTARY

Over the past year, the Consumer Staples sector has significantly lagged the World Index +3% vs +18% on a total return basis. However, this overstates the average performance which was helped by sector giants, Costco's +51% (\$365bn mkt cap) and Walmart's +31% (\$551bn). Contrast that with two of the worst performers (and far smaller companies), Walgreens Boots Alliance -58% (\$10bn) and Remy Cointreau -51% (€3.7bn) and you can easily see the outsized impact of the giants in market cap weighted sectors.

We like to look for potential opportunities in unloved sectors, but this requires detailed analysis because "the market" is often "correct" and a lower share price does not automatically mean the company offers value – Walgreen's declining operational performance and large debt load seem to us to be valid reasons for their share's poor performance.

So why has the Consumer Staples sector underperformed the World Index? Many of these companies increased prices during the COVID period, citing inflation, but in recent quarters we've seen evidence of the consumer now wanting "value" and trading down to "private label", pressuring the growth of some consumer brand companies. Hard liquor companies like Diageo and Brown-Forman are suffering from declining sales in keeping with the trend of fewer people drinking alcohol these days, and lastly Consumer Staples companies are less "exciting" to own than technology companies in days when technology shares were rising 2% every day.

However, within this space, we have been building a few positions and are now substantially overweight this defensive sector. One of these holdings is Molson Coors, one of the world's largest brewers with brands such as Coors Lite, Miller Lite, Carling and Madri Excepcional. In 2016 MolsonCoors exercised their right to acquire SABMiller's 58% stake in their Joint Venture, MillerCoors, which they funded with \$9bn of debt. However, rather than gear up their balance sheet during times of low interest rates like many other US listed companies, this conservative management team have repaid \$6.2bn of this debt from cash generation. We like conservative management teams. Beer is less susceptible to private label erosion and they benefitted from the consumer boycott of Bud Light helping them grow sales in a difficult market. Despite growing earnings by 34% over the past year, the share price has fallen 22% and today trades at less than 10x earnings and offers a 3% dividend yield. A defensive company like MolsonCoors is just what we want in these turbulent times.
