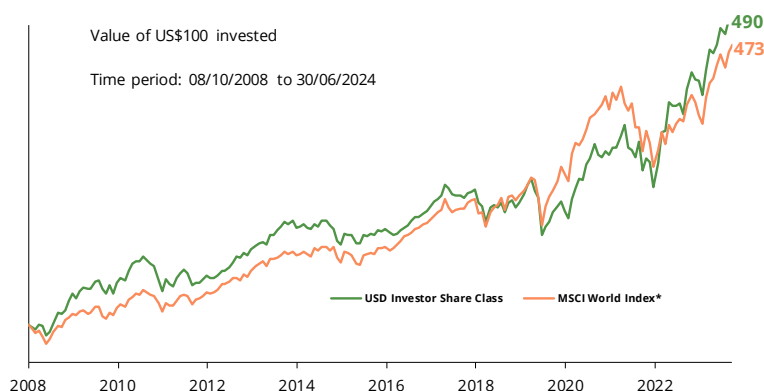

COMMENTARY

June was a difficult month for us. To put some context to the performance – the World Index was up 2%, but Europe was down 2.4%, Hong Kong was down 1.9% and Japan was down 1%. Large US technology companies were particularly strong, up 9% for the month. We only have 20% of our assets invested in US equities and 80% invested elsewhere, almost the opposite of the MSCI World Index.

Under-performance is either due to mistakes causing a permanent loss of capital (eg. substantially overpaying for expected earnings that don't transpire), or the emotion of fear driving prices lower temporarily. We work hard to avoid mistakes that result in a permanent loss of capital, but when fear impacts prices, opportunities present themselves, and it's often a time to "sow seeds for future harvesting". In early June, Macron shocked the market when he announced a snap election, and since markets don't like uncertainty, shares across Europe fell, with the French market falling 6%. Our European holdings cost us 1.3% of performance, with the largest loser being Carrefour, the French-listed food retailer, down 12% for the month.

There was no change in Carrefour's business model, nor its long-term outlook, and regardless of the outcome of the French election, people will still need supermarkets in France (and Brazil and Europe more broadly). Unfortunately, Carrefour simply happened to be in the "wrong neighbourhood" this month. At 7 times earnings and a 6% dividend yield, we find the company even more compelling.

The Hong Kong market was also weak with our holdings in this market "costing" almost 1% in the month. The largest loser here was Baidu, the Chinese technology company engaged in search, cloud, AI, and autonomous driving. In many ways Baidu is the Chinese "Google" priced at 11 times earnings with more than half its market cap in net cash.

We use market volatility as an opportunity to rotate from holdings trading close to our fair value into some of these "innocent bystanders", thereby enhancing our Fund's expected return profile. We look forward to, we think, "harvesting" these seeds in the future.

UCITS funds are required to calculate an Ongoing Charges Figure (OCF). It is a measure of the costs of operating the Fund. It is calculated in accordance with a methodology published by European regulators. The OCF of the Fund was 1.30%, calculated based on operating expenses of the Fund for the 12 month period ended 31/12/23 as a percentage of average Fund net assets of \$88.9m over the same period. The OCF includes all fund operating expenses for the USD, GBP and EUR investor classes, but excludes the 0.5% payable to the financial intermediary for the USD Advisor class.

The OCF figure is not applicable to the USD Institutional class. 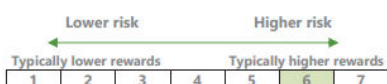
