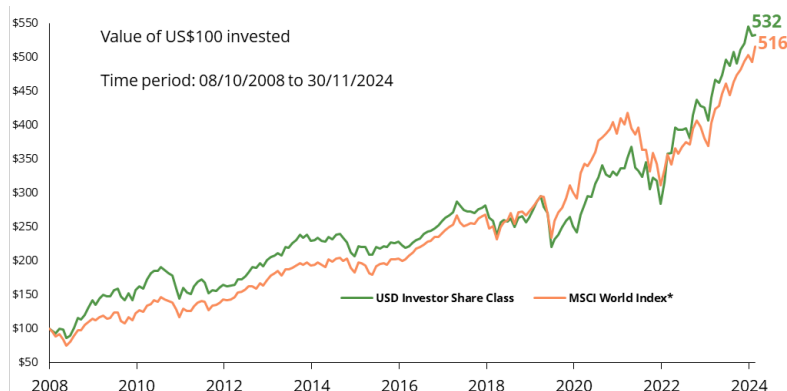

COMMENTARY

November was a disappointing month. While we didn't lose money in USD terms, we also didn't participate in the post-Trump election euphoria because most of our portfolio is invested in companies outside the USA. The weak GBP and EUR over the month negatively impacted performance by 1% when measured in the strong USD.

Being significantly underweight the USA relative to the major benchmarks raises some eyebrows, but we worry more about the risk of capital loss than being differently positioned to benchmarks. Most US equities are expensive relative to historical valuations and international peers and over the long-term that means lower returns and higher risk of capital loss. Euphoria over "Team Trump" is high - Tesla's 38% rise in the month was alone responsible for 13% of the MSCI World Index's move, an index with 1397 constituents. The company now has a \$1trn value, equal to 23x the value of BMW despite only growing sales 1% over the past year and generating less net income than BMW. We prefer being exposed to companies that have upside potential with limited downside risk, so if robotaxis are very profitable, we have that exposure via Chinese company Baidu. The difference is that Baidu already makes \$1bn a quarter but has ~75% of its \$30bn market cap in net cash, limiting the downside.

One positive of Trump's election is that corporate takeover activity may increase as regulators are forced to step back. This may benefit funds such as ours which have meaningful exposure to mid-sized companies that could be takeover targets in this environment.

One mid-sized USA company that we hold is Mattel, which has a market capitalisation of less than \$7bn. Mattel is the world's #2 toy company but #1 in dolls and vehicles, with well recognised brands such as Barbie, Hotwheels, Matchbox and Fisher Price. Mattel's astute management team have successfully turned the company around and are building upon the success of the Barbie movie by working to monetise their other content - they currently have 14 projects underway at leading studios such as Netflix, Amazon, Sony and Apple. At 12x earnings, with strong free cash flow generation and a \$1bn buyback, we think Mattel is well placed, even if it isn't subject to M&A activity.
